Guarantee

- 1.2 Smiths News may without notice to or consent from the Guarantor(s) and without reducing, or extinguishing the Guarantor's liability:
 - 1.2.1 Renew, modify, release or abstain from perfecting or enforcing any security or guarantee now or hereafter held from the Body Corporate or any other person, including any signatory to this Guarantee, in respect of the indebtedness, liabilities and other sums due to Smiths News from time to time;
 - 1.2.2 Grant time or indulgence to or compound with the Body Corporate or any other person or guarantor, including any signatory to this Guarantee; and
 - 1.2.3 Do or omit to do anything, which, but for this provision, might operate to exonerate or discharge this Guarantee.
- 1.3 This Guarantee shall be a continuing security until all the indebtedness, liabilities and other sums due to Smiths News from time to time shall have been discharged and it shall remain the property of Smiths News and/or its successors.
- 1.4 Each of the parties intend that the guarantee provisions contained within this document be a deed and confirm that the Guarantee is executed and delivered as a deed, notwithstanding the fact that any one or more of the parties may only execute it under hand.
